8. **Environment Committee:**

Ownership of the Pantiles: Members will recall that at the Full Council Meeting 16th January, concerns were raised in relation to the cost to transfer the land and it was unanimously agreed that this matter required further consideration. A further quotation for the legal costs has been obtained and it was agreed that Ferring Parish Council to take ownership of the land is still the preferred option and will be recommended to Full Council. Councillor Roger Elkins will seek advice from a Drainage Officer at ADC for clarification with regards to the transfer/ownership of the ditch.
