04-10-2016 Minutes of the Council Meeting held on Monday 5th September 2016

The Minutes of the Full Council Meeting of Council held on Monday 5th September 2016 were approved by Council and signed by the Chairman presiding as a correct record with the following spelling amendments:

a) Environment, Footpaths and Amenities, no meeting held

Councillor Geoff Mines reported on the following items:

- Sea Lane boat is now in situ and has been planted with appropriate plants.
- The Warren Pond annual clearance took place 15th October to remove brambles, weeds etc. A number of volunteers were involving Conservation Group members and Parish Councillors. This small natural habitat has welcomed a heron recently and the number and range of ducks has also increased. It was acknowledged that the fencing at the pond may need repairing or replacing sometime in the near future.

b) Community & Facilities, no meeting held

In the absence of Councillor Terry Jackson, Councillor Stephen Horne reported on the following:

- Councillors have been provided with a copy of the draft Risk Management Background documentation. It was agreed that title Image/attitudes should be amalgamated into title Councillors & Officers propriety.
- With the above amendment, Councillors approved the Risk Management Background document.
- Councillor Stephen Horne and the Assistant Parish Clerk were thanked for their time spent and effort with this project.

a) Arun District Councillor Roger Elkins reported the following points:

- The Local Plan Subcommittee met and further assessments and key elements are being considered, these include viability, infrastructure and landscaping. This is an ongoing study and as per the Inspectors request, the proposed housing numbers in the draft local plan are being reviewed.
- Details of a landscape study in the district were disclosed. It was agreed that the Parish Clerk will forward the website link to Councillors.
- The new swimming and leisure facility in Littlehampton project is moving forward.
- ADC is facing financial challenges in relation to business rates. This also includes reduction in Government grants however ADC finances are in good order.
- It was reported that there is a proposal to amend the boundaries and the amount of meetings per year for the County Local Committees.
