ANNUAL PARISH MEETING - Unfortunately, the Annual Parish Meeting for 2020 has had to be cancelled due to the current restrictions. The Annual Parish Meeting was established in 1894 and consists of the local government representatives and the residents of a parish. It usually contains presentations of reports by the Parish Council and by District and County Councillors. The purpose of the meeting is to discuss parish affairs with residents.



ANNUAL MEETING OF FERRING PARISH COUNCIL - This is a statutory meeting and due to the present restrictions arrangements to hold the AGM are currently being reviewed in line with regulatory advice. The principal business and first agenda items are to elect a Chairman and then a Vice-Chairman of the Parish Council. The committee structure is also likely to be agreed at this meeting and the normal business of the council proceeds in accordance with the published agenda. The Parish Council is scheduling to pursue with this meeting using a remote internet platform on Tuesday 26th May 2020.



WAR MEMORIAL - The memorial is looking resplendent again following an inspection and thorough clean by a professional monument company, as planned, in time for the 75th anniversary of VE day on 8th May. VILLAGE GREEN - The Village Green is receiving some particular attention with visible improvement from a revised grass cutting procedure. Work on the frontage opposite the shops continues although it has suffered delays due to the exceptionally wet autumn/winter conditions and then the operational impacts of the pandemic. Arun District Council contractors will be progressing with the weed control, seeding and replanting as their disrupted schedule permits.



BONFIRES - Arun District Council advice in relation to Bonfires: Smoke and smells from bonfires can aggravate respiratory problems such as asthma, bronchitis and COPD and affect those with heart complaints, causing breathing difficulties to those most vulnerable to Coronavirus. Do not burn garden waste, paper, or any other waste, under any circumstances and be mindful of neighbours and fellow members of the community.



HIGHWAYS ISSUES – Discussions have been held with Compass bus and WSCC concerning the route through Ferring. At this stage there is no agreed solution. The Parish Council has addressed the issue of parking at the north end of Langbury Lane to WSCC but no solution has been agreed.



THE GLEBELANDS OPPORTUNITY - Work continues on the GPG Project but is limited in this current situation. An extension in principle has been agreed with WSCC for any decision on this project, due to the current need to postpone public consultations.



SPEED MONITORING - In response to comments from residents, the Vehicle Activated Speed Sign has recently been deployed on Sea Lane (northbound at the junction of St Malo Close) and at Ferringham Lane (heading into the Village from the A259 before the left-hand bend). In both locations, 3 -5 % of vehicles exceed the speed limit, however less than 1% are travelling above 35mph. Vehicle numbers have decreased by around 50% since the Coronavirus prevention measures were introduced. KEEP FERRING TIDY - The Parish Council have been made aware of an increasing problem with litter and dog fouling within various locations of the village. There are numerous litter and dog bins located around the village. Please 'pick up' and dispose in the correct bins provided around the village. Thank you for helping to keep Ferring tidy.



ADC PUBLIC SPACES PROTECTION ORDER (PSPO)
Arun District Council has formally agreed the introduction of a new Public Spaces Protection Order (PSPO) to tackle anti-social behaviour in the district, effective from 1 April 2020. This places a control on drinking alcohol and requires people not to behave anti-socially in public places. LOVE WEST SUSSEX MOBILE APP – This is a West Sussex County Council (WSCC) Mobile Application. Residents can report environmental issues such as highways matters including potholes, damage to street furniture or fly-tipping through their mobile phones; WSSC will manage and respond using their integrated services.
